

# Terms of Use

Updated: January 6, 2008

These Terms of Use apply not only to the OrganizeMyLeague software / web site, but also to other web pages and software developed by C & G Associates that help you manage all aspects of your sports league.

By accessing and / or using the OrganizeMyLeague software / web site or other web sites or software developed by C & G Associates, you are expressly agreeing to comply with and be bound by these Terms of Use and the C & G Associates Privacy Policy, as well as all applicable laws and regulations.

## Intellectual Property Rights / Ownership

You acknowledge that C & G Associates owns all rights, title, and interest in the OrganizeMyLeague software / web site and all other software developed by C & G Associates covered by these Terms of Use and the C & G Associates Privacy Policy. You further acknowledge that C & G Associates owns all rights, title, and interest in all web site content including text, logos, graphics, buttons, images, photographs, software, etc.

## Licensing

Your right to use license covers one and only one league. For purposes of these Terms of Use, a league is defined as follows:

1. A league (also known as an Association) is comprised of one or more teams at different age / skill / playing levels representing a specific organization or geographic area. A group of leagues make up a Conference. For example, a youth football league may be made up of teams at different playing levels (Mites, Jr. Pee Wee, Pee Wee, ...) representing a single, city, town, or geographic area. These leagues / Associations play games at each playing level against other

leagues / Associations as part of a higher level organization, known as a Conference. Each league / Association must have their own license to use the OrganizeMyLeague software / web site.

2. A league can be comprised of one or more teams that compete at a single location. For example, a baseball league may be defined as a number of teams that all compete at the same playing field at different times and / or on different days. A bowling league may be defined as a group of teams bowling at the same bowling center at the same time on a regularly scheduled basis.

C & G charges an annual license fee for your use of the OrganizeMyLeague software / web site. The annual license cost will be determined by C & G Associates by October 1 for the upcoming year. You will be informed via email of any changes in the annual license fee on or before November 1.

C & G Associates reserves the right to offer promotional pricing, multi-year discounts, and volume discounts on the OrganizeMyLeague software / web site at its discretion.

C & G Associates reserves the right to cancel your license to use the the OrganizeMyLeague software / web site at any point without a refund for violations of these Terms of Use or the C & G Associates Privacy Policy.
